Please have appropriate weights to hold your tent in place in the case of wind. **If you are applying to the Festival for the first time, please submit a copy of your work (three photo's will be sufficient).**

**Space is limited to the first 110 artists.**

## Step 3: Artist / Artisan Agreement

I, the artist/artisan, agree to abide by the following conditions for acceptance into the **2021 Festival by the Sea**:

All artworks/objects to be displayed for sale must be handmade and not in any way manufactured, mass produced, or assembled from commercially sold kits.

Set up begins at 8 a.m. on the day of the event. The event will take place between 10 a.m. and 6 p.m. Artist may dismantle their booths at 6 PM.

All work to be displayed for sale will be representative of the photos provided when juried. The Festival by the Sea committee reserves the right to remove, without refund or recourse, *any* exhibitor who misrepresents themselves or their work in this application.

Artists and Artisans will comply with all applicable local and state regulations. There will be no open flames in any display. Artists & Artisans are responsible for all applicable sales tax, vendor licenses and or state licenses and appropriate insurance coverage.

All Artists & Artisan displays are expected to be conducted in a manner in keeping with the character and quality of the event, and the town. All excess stock, wrapping materials, bags and boxes must be stored out of sight. Any Artist or Artisan who fails to appear forfeits their right to exhibit without refund or recourse unless written permission is obtained prior to the event.

The Festival by the Sea, its agents, officers or volunteers will not be held liable for failure to perform or fulfill its contractual obligations provided such failure is caused or impeded by closure of the site location due to factors beyond the control of the event organizers. The Chamber, The Festival by the Sea Committee and the Town of Manchester-by-the-Sea will not be held responsible for any loss, damages or injury caused by products sold or exhibited by Artists or Artisans directly or through warranty expressed or implied. Insurance for such loss, damages or injury is the sole responsibility of the Artists or Artisans. The show is held in rain, shine or snow. In extreme cases, the show hours may be altered or cancelled, and not re-scheduled. There will be NO refund of fees issued in the case of cancellation of the Festival by the Sea.

It is agreed that the Festival by the Sea Committee reserves the right to amend and/or add to the applicable rules pertaining to the governing of this event. The interpretation of all rules by the Cape Ann Chamber and/or the Festival by the Sea Committee is final.
